# "VACANCY TAX" – VOTE "NO"! It is not the solution... MEASURE NEEDS EXPERT LEGAL REVIEW



I want to thank the City Council for directing that further review be made on the proposed "vacancy tax." It is important that city officials and the public have all the information they need about the matter before deciding <u>to treat second</u> <u>homeowners like second class citizens.</u> Please rephrase...

According to our fine city staff the city council directed the following action at their May 7, 2024, meeting:

"City Council passed a motion requesting an Elections Code section 9212 report for the Vacancy Tax Citizens Initiative to be presented at the June 18 City Council meeting to cover its fiscal impact, its effect on the use of land, availability of housing, and ability of the City to meet its regional housing needs, and its impact on funding for infrastructure including transportation infrastructure, contingent upon the City Clerk certifying the sufficiency of the petition. City Council further directed the report to include fiscal impacts (positive and negative), high-level legal analysis, implementation costs, privacy impacts, market value real estate impact, and best method to determine vacancies."

The report will "not include whether the title/summary is legal. The consultant is assisting with the quantitative analysis, and the City Attorney is preparing the legal analysis as this was discussed at the City Council meeting."

Below is an excerpt from my letter to the City Council before taking action at their May 7, 2024 meeting urging them to do the following:

"...The City Attorney has already publicly stated that a vacancy tax for the City of South lake Tahoe is questionable legally. **Ibelieve that she is correct. I thank her for her candor when the matter first came before the Council.** Current litigation regarding the tax is in charter cities. As you know, SLT is a general law city.

*First, the name of the ballot measure is misleading and incorrect.* The properties in question are second homeowners and are not vacant. They are occupied by their owners for a portion of the year. The ballot measure title was deceptive and inaccurate and may have left the public who was asked to sign the initiative with the impression that the homes were essentially unoccupied.

<u>Second, the single-family homes targeted for taxation are not being offered for rent</u>. They are second homes. They are not part of multifamily units commonly rented.

Third, requiring people with second homes to rent them by taxing them if they do not, is arguably a taking under Federal law.

*Fourth, I am told that requiring people to rent their homes by coercion through taxes violates State law.* 

Fifth, I would argue that taxing single family homes differently on the same street in a singlefamily area simply because the owner of one does not live in the house full time or does not rent the unit is discriminatory and illegal.

The City Council needs to retain special expert counsel to advise them on the legality of the entire measure considering our situation here. If the measure passes, it will be litigated. The City Council should not wait and needs to know what is legal or not legal before deciding whether to pursue the ballot measure. If I were on the city council, I would urge retaining the law firm that is litigating the matter in San Francisco. (Nielsen Merksamer). (1) This is no time for best guesses on this serious matter. The City's elected leaders need a definitive answer to the legal questions raised and the validity of the ballot measure title and the impact on signature gathering that occurred. If special counsel is hired, they should report directly to the city council, minus the VT council member proponent for obvious reasons relating to a conflict of interest. The City Council needs unfiltered information before deciding whether to pursue the measure and defend it if it passes.

The Council cannot be expected to support or defend measures that are arguably illegal and use taxpayers' funds and legal staff's time to defend an illegal measure whether or not it passes. Hypothetically, if an initiative were proposed that discriminated against people

#### based on their religion, gender, gender identity or race, the City Council could not and should not promulgate such a measure or defend it if it were somehow to pass.

I suggest that the issues identified above be evaluated as part of your efforts to evaluate the impact of the proposal under the provisions allowed for in your staff report under item 8."

#### Re: PRESERVATION OF AFFORDABLE HOUSING FROM DEMOLITION <u>BY A STATE</u> AGENCY – Follow-up

Dear Attorney General Bonta:

I and many affordable housing advocates would

appreciate hearing back from you that your office will assist us in preserving existing affordable housing in South Lake Tahoe (Motel 6) from demolition by a State agency, the California Tahoe Conservancy.

Contrary to what some local officials have said recently and may have been said to you, the 74 units in question are perfectly habitable and not ones that are in a poor condition. The



reuse of these units for workforce housing for existing locals and seniors in need would be far less cost than constructing new units elsewhere. Destroying these units is a wasted affordable housing opportunity, arguably a violation of the letter if not the spirit of State housing law, a violation of the City of South Lake Tahoe's general plan and Housing Element, and a waste of public money. State government can and must do better and not allow a State agency to ignore the Law and the need of residents in need of housing.

We can protect our environment and preserve existing affordable housing. *Please help us.*
